

ADDENDUM TO FOODSERVICE AGREEMENT

ADDENDUM to the Foodservice Agreement dated the 5<sup>th</sup> day of October, 2020, by and between Sauk County Sheriff’s Office, (hereinafter referred to as “Client”) and Consolidated Correctional Foodservice, a division of Consolidated Management Company (hereinafter referred to as “Consolidated”). This addendum is for the period beginning November 29, 2021. All provisions of the Agreement shall continue as written except for the following changes:

WHEREAS, Consolidated operates the food service for the Sauk County Jail facility located at 1300 Lange Court, Baraboo, WI 53913 (the “Facility”); and

WHEREAS, Client wishes to retain Consolidated to provide senior meal food service for ADRC of Eagle Country Sauk County-Baraboo Office (hereinafter referred to as “ADRC”), West Square Building, 505 Broadway, Baraboo, WI 53913, and Consolidated is willing to undertake such responsibilities on the terms and subject to the conditions set forth herein.

- a) Consolidated will provide approximately 145 hot lunch meals Monday-Friday (meal count to be provided by ADRC one week in advance), except for holidays and days when the Baraboo School District is closed. ADRC will notify Consolidated no later than 0700 if the School District is closed for inclement weather.
- b) Consolidated will invoice the Client \$3.50 per meal on a weekly basis. Client shall pay Consolidated within fifteen (15) days after receipt of the monthly statement.
- c) The senior meal provided is the same meal as prepared for trustees at the Facility.
- d) ADRC has reviewed and confirmed that the dietician certified menu dated August 16, 2021, served at the Facility meets the ADRC nutritional guidelines. Any menu change requested by either party will be negotiated prior to implementation.
- e) The senior meals are prepared and served in bulk in ADRC’s supplied warming trays and carts separated for delivery by four locations.
- f) ADRC will pick up the meals at 0930 daily and transport meals from the Facility to the delivery locations
- g) ADRC will return the warming trays and carts to the Facility by end of day

The initial term of this Addendum (the “Initial Term”) shall begin on November 29, 2021, and shall continue until May 27, 2022. This Addendum may be terminated by notice in writing given by either party hereto to the other, at least 30 days prior to the end of the then-current term.
