Call to order and certification of compliance with Open Meeting Law at 9:00 A.M.

Canvassers reviewed the zero report tapes to verify all totals were zero at the beginning of the night on the tabulation equipment. Votes cast at the February 21, 2017 Spring Primary Election were verified reviewing the highest number of votes cast is the same or less than the highest numbers of voters reporting on poll lists, and verifying that the number of ballots cast is the same or less than the highest number of voters on the poll lists. Inspectors' Statements and Incident Logs were also reviewed and canvass incidents and adjustments noted.

Provisional ballots were canvassed and counted. No discrepancies were noted.

Items of note:

Town of Franklin: One voter cast a ballot in Ward 2 that should have been cast in Ward 3, therefore the counts were off by one in each ward.

City of Wisconsin Dells: Two voters from Columbia County got Sauk County ballots. Total number of ballots cast in Sauk County should be 3, resulting in (-2) for T. Evers.
