- 5. Business Items for Discussion and/or Action:
  - A. Tara Hayes gave an update for the accreditation process. Tara reported that we continue to work on processes, policies, and documentation for this coming year's annual report.
  - B. Tara Hayes provided a written Director's monthly report to all Board of Health members via Granicus. We went through the report program by program. She also gave a report of the Community Health Needs Assessment (CHNA) and the top three priorities; Substance Abuse, Mental Health and Obesity. Affordable housing and chronic disease was a close fourth and fifth place need. We will now be working on the Community Health Improvement Plan (CHIP). This is the follow-up to the CHNA, what we implement next to work on the priorities. Tara also provided a Coalition update via a report on Granicus. Reported on our current outreach to schools and local leaders regarding the Juuling (vaping)

trend among area youth in our communities. Looking into having local school districts participate in the Youth Risk Behavior Survey (YRBS). So that we can apply for the Drug Free Communities grant. The data from the YRBS survey could provide a valuable resource and identify key areas of concentration for the action plan.

We also reviewed the Environmental Health Report provided on Granicus.
