

At the Municipal Level...



Reedsburg - The City of Reedsburg received a sizable growth in residential units in 2024. In the past year, the City saw or currently sees the construction of 33 single and two-family houses, which includes 12 townhouses and 11 workforce housing duplexes. As part of the workforce housing development, there are 32 additional apartment units that the city assisted the developer with through tax increment financing.

The City purchased several acres of vacant infill land in 2023. That area is intended for a 55+ population that will consist of apartments, duplexes, and townhomes as well as accessory recreational amenities. The first six duplexes are complete along with near completion of the 56-unit apartment building. Phase 2 of the duplex construction is planned to start in December.

A 48-unit apartment building is currently under construction on Viking Dr. This is the third of the three planned buildings and will open in 2025. The former South School continues its transformation by renovating the previous classrooms into apartments. There are at least eight apartments in use today.



Spring Green - The River Valley Housing Coalition is using the information in its regional housing report to continue to support municipalities and others in the area. Upcoming projects for the Coalition include:

- 1. Mapping available land and vacant houses/buildings. This map will then be available online for interested parties.
- 2. Holding monthly educational opportunities to learn from others who have implemented specific strategies of interest to the Coalition. This project is generously supported by the Wisconsin Economic Development Corporation.
- 3. Collaborating with area libraries to share more information about the Coalition, the report, and upcoming initiatives.
- 4. Delving into the survey data from the report to learn more about the needs of specific target populations.
- 5. Securing additional funding to support the coordination of the coalition.

With millions of households still struggling with the high costs of housing and healthcare as we start 2025, the ABA Commission on Homelessness and Poverty, HealthBegins, National Center for Medical-Legal Partnership, and RESULTS Educational Fund are co-hosting a conversation to examine 1) the undeniable link between housing stability and health and 2) how the healthcare system can address housing precarity, prevent homelessness, and improve health outcomes of whole communities.

DHS Announces Innovative Medicaid Housing Benefit

Starting February 1, 2025, Wisconsin will launch a new initiative to provide housing support services to Wisconsin Medicaid members experiencing housing insecurity who are also affected by substance use or mental health conditions. Wisconsin is one of the first states in the country to use housing solutions funded through Medicaid to achieve improved health outcomes for members.

"This new program offers a support system grounded in the stability, dignity, and well-being that secure housing can provide," said Wisconsin Department of Health Services (DHS) Secretary-designee Kirsten Johnson. "For people who are struggling with substance use or mental health challenges, having a place they can call home can significantly improve their overall health and quality of life." WI Launches Home Energy Rebate Programs

Rebates for low- and moderate-income households will help save energy and money when switching to energy-efficient home upgrades and appliances

HOMES Program: \$74.8 million was made available to support whole-home energy efficiency improvements, including insulation, air sealing, heating, ventilation, and air conditioning upgrades. All Wisconsin households are eligible. More info is available here.

HEAR Program: In 2025, rebates will be available for insulation and air sealing that require contractor installation. Customers will also receive instant rebates for appliances, such as electric clothes dryers, electric stoves, and insulation bought at stores or through a contractor. More info available here.
