7. Review and Approve Expenses - Circuit Court

Motion by Deitrich, seconded by Schell to approve payment of the Circuit Court expenses in the amount of \$1,357.76 and to approve payment of Jury expenses in the amount of \$6,398.76. Bills discussed. Motion carried.

8. Departmental Update and Approve Expenses – Register in Probate

Revenue and expenses both on track for the month. Caseload is steady and staying on track.

Motion by Clemens, seconded by Harris to approve payment of the Register in Probate expenses in the amount of \$9,809.76. Bills discussed. Motion carried.

9. Departmental Update and Approve Expenses - Child Support

Collections are down a little in May and for the year. Measures are looking good & at almost 80%. Received contract amendment from Department of Children & Families that gives us an additional \$3,816 for this year. Expenses on track & budget looks good.

Motion by Peper, seconded by Clemens to approve payment of the Child Support Agency in the amount of \$3,050.83. Bills discussed. Motion carried.

10. Departmental Update and Approve Expenses - Court Commissioner

Family law clinic has been busy. Budget on track.

Motion by Deitrich, seconded by Alexander to approve payment of the Court Commissioner expenses in the amount of \$1,248.58. Bills discussed. Motion carried.

11. Departmental Update and Approve Expenses - Clerk of Court

Interpreter expenses are a little higher this month as one interpreter submitted invoices for March, April & May. Interpreter candidate did not pass oral test and will test again in December. Currently only have 2-3 interpreters so scheduling on Tuesday & Wednesdays to keep expenses down. Budget is on track.

Motion by Clemens, seconded by Peper to approve payment of the Clerk of Court expenses in the amount of \$38,556.70. Bills discussed. Motion carried.

12. Departmental Update and Approve Expenses – District Attorney

Budget is on track. Victim witness reimbursement has been submitted for the 1st half, budgeted for 51% and hoping to get that. Case numbers are comparable to last year. Law student intern started in May and will be here for 10 weeks. New ADA started as a state employee on June 3rd and up to 7 attorneys in the office through the end of the year.

Motion by Schell, seconded by Peper to approve payment of the District Attorney expenses in the amount of \$876.23. Bills discussed. Motion carried.

13. Operations Update - Sauk County Animal Shelter

14. Departmental Update and Approve Expenses - Coroner

Invoices standard, extra packaging was body bags & orders usually twice a year. Usually do about 3 autopsies a year and around 50 drug tests.

15. Departmental Update and Approve Expenses - Sheriff

Calls for service for last month were 6985. Offender days 1017. Profit on GPS monitoring was \$19,380.55. We are switched over to the new jail medical provider and is going well with them.

Motion by Schell, seconded by Deitrich to approve payment of the Sheriff's expenses in the amount of \$256,528.79. Bills discussed. Motion carried.
