Motion carried, unanimously.

e. <u>Discussion and possible action to award a contract to Berglund Construction Company for</u> renovations to the Firehouse at the Sauk County Farm – M. Krueger noted that in discussions with the Director, this item is under negotiations and is not ready for approval. M. Krueger stated that the item would need to be postponed until the July 23rd meeting. Motion by Lohr/Eberl to postpone the action to award the contract to Berglund Construction Company for renovations to the Firehouse at the Sauk County Farm until the July 23, 2024, LRE Committee meeting. Motion carried, unanimously.
