



1 - WHITE MOUND COUNTY PARK

57995 White Mound Drive, Hillpoint, WI 53937

At approximately 1,100 acres, White Mound County Park is Sauk County Parks + Recreation's headquarters and the County's largest park. At the heart of the park is a 104 acre lake that may be used for fishing, paddle sports, swimming and boating (at a slow-no-wake speed). Types of fish found include panfish, largemouth bass, northern pike and catfish. Paddle sport rentals are available at the office. There is an extensive system of trails throughout the park, open for hiking, snowshoeing, horses and snowmobiles (weather permitting). An abandoned limestone kiln can also be found at the park. The park offers a tent and RV campground, as well as a horse campground for those who bring their own horses. Many astronomers visit the park to utilize the distinguished quality of starry nights. Scattered around the park are many picnic areas that include playgrounds, grills, picnic tables, bathrooms and a shelter (available to rent for a fee). The Prairie Smoke Terrace building is also available to rent all seasons and seats about 64 people indoors. Hunting and trapping are allowed in many areas of the park. There is ample parking and an entrance fee is required.



2 - SAUK COUNTY FARM

S4555 County Road CH, Reedsburg, WI 53959

This 565-acre parcel is mainly farmland and pasture. Although there are no longer visible headstones, the property also is home to the Sauk County Farm Cemetery. Some areas are open to public access for hunting, fishing, hiking, wildlife observation and other uses. There is no entrance fee at this property.



3 - LAKE REDSTONE COUNTY PARK

S4522 Douglas Road, LaValle, WI 53941

At approximately 30 acres, this park has a large parking lot that gives access to a playground, beach and waterfall. There is one unmarked hiking trail. Lake Redstone County Park is a popular spot to fish for panfish, largemouth bass, musky, northern pike and walleye. Bathrooms are provided and an entrance fee is required.

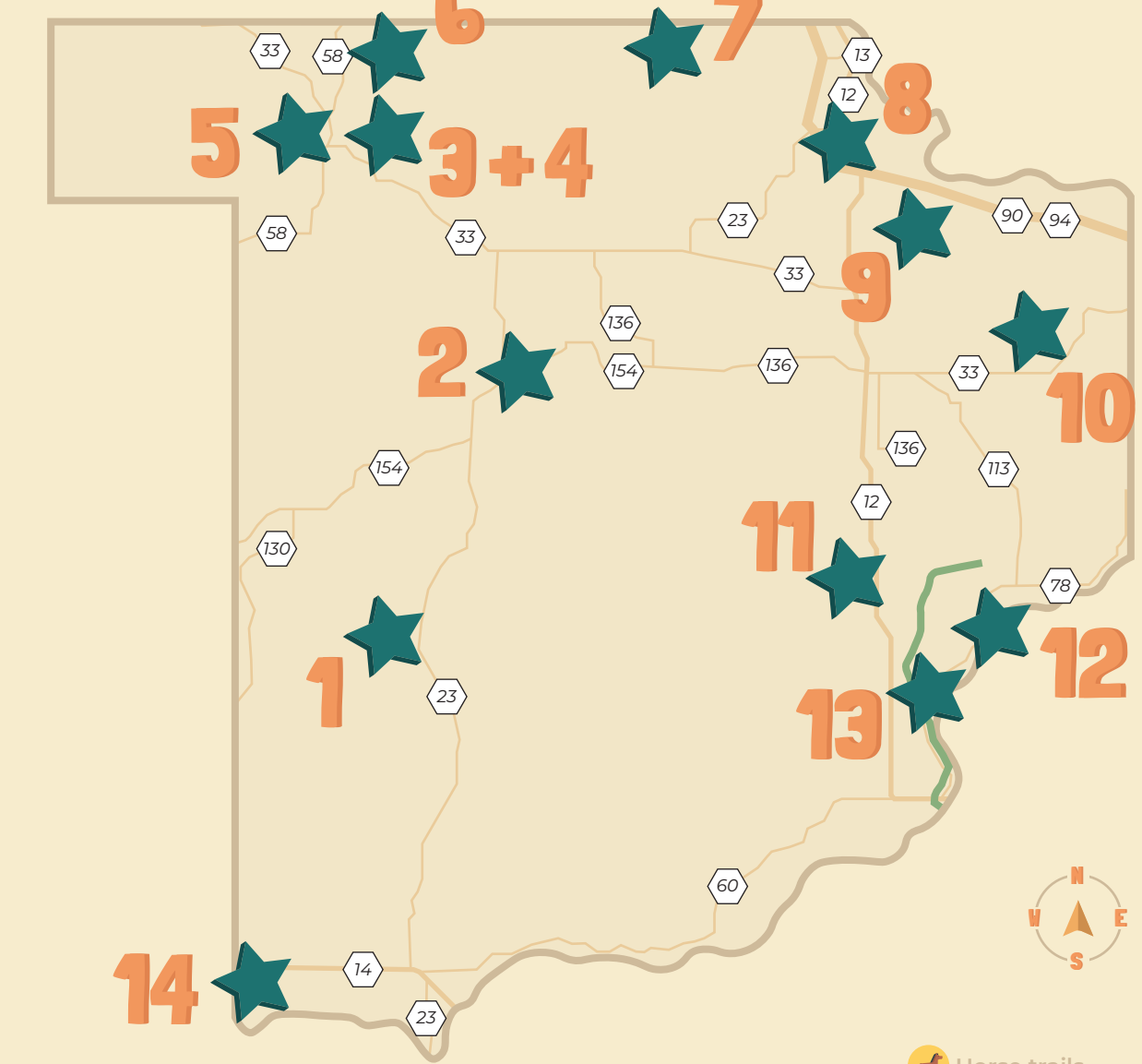


4 - DOUGLAS LANDING

E4603 Douglas Road, LaValle, WI 53941

Douglas Landing provides access to the Baraboo River and provides a quiet spot to fish. There is no entrance fee required at this property.

5 - HEMLOCK COUNTY PARK

E3601 North Dutch Hollow Road, LaValle, WI 53941

Hemlock County Park has much to offer in almost 73 acres of property – offering picnic tables, grills and an ADA accessible bathroom. There is an unmarked hiking trail and access to fishing from many spots around the slough. The 16-acre slough provides opportunities to catch northern pike, largemouth bass and panfish. Archery and shotgun hunting are also available in this park. No muzzle-loaders are allowed. No entrance fee is required.



6 - NORTH END BOAT LANDING

S4765 LaValle Road, LaValle, WI 53941

This landing provides a launch for canoes, kayaks and boats to Lake Redstone. Fishing opportunities via the ADA fishing pier include panfish, largemouth bass, northern pike, musky and walleye. A bathroom is provided during the summer months and an entrance fee is required.



7 - WEIDMAN WOODS

S442 Town Hall Road, Reedsburg, WI 53959

Weidman Woods provides another area to explore nature at approximately 130 acres. There are unmarked trails, archery and gun hunting are allowed at this property and no entrance fee is required.



8 - TIMME MILL DAM

South Burrirt Avenue, Wisconsin Dells, WI 53965

Timme Mill Dam provides a canoe and kayak launch to Mirror Lake. Parking is located by the dam, or at a parking lot located off of South Burrirt Avenue. Fishing opportunities include largemouth bass, walleye, panfish, northern pike and catfish. There is no entrance fee required at this property.



9 - YELLOW THUNDER MEMORIAL

S2653 County Road A, Baraboo, WI 53913

Yellow Thunder Memorial honors Chief Yellow Thunder. The site is a catalogued burial site and no entrance fee is required at this property.



10 - MAN MOUND NATIONAL HISTORIC LANDMARK

E13085 Man Mound Road, Baraboo, WI 53913

Man Mound National Historic Landmark is named after the rare, man-shaped effigy mound found on the property. Picnic tables and benches are provided at this park. No entrance fee is required.



11- BLUFFVIEW COUNTY PARK

E11073 Center Road, North Freedom, WI 53951

At 3.58 acres, Bluffview County Park contains an accessible playground and space for gathering. There are picnic tables available and an overlook of a small pond. Parking is available along East Road. There are no bathrooms available and no entrance fee is required.



12 - SUMMER OAKS BOAT LANDING

E12614 Kilpatrick Point Drive, Merrimac, WI 53561

With access to Lake Wisconsin, the Summer Oaks Boat Landing provides parking for boaters with opportunities to catch smallmouth and largemouth bass, northern pike, walleye, panfish, trout, catfish, musky and sturgeon. A bathroom is provided during the summer months. An entrance fee is required.



13 - GREAT SAUK STATE TRAIL (PARKING)

E11760 County Road Z, Prairie du Sac, WI 53578

The Great Sauk State Trail (GSST), designated by the State of Wisconsin as a State Trail in 2016, is a 11.8 mile paved recreational trail that connects the Sauk Prairie Communities of Prairie du Sac and Sauk City with the Sauk Prairie Recreation Area. Bikers and rollerbladers are required to obtain a day or annual state trail pass. There is no entrance fee for vehicle parking.



14 - SAUK COUNTY FOREST

S12604 Porter Road, Spring Green, WI 53588

With unmarked walking trails and 677 acres to hunt, the Sauk County Forest has plenty to explore. Archery and gun hunting are allowed and no entrance fee is required.
