## **Kraemer Library & Community Center, Plain – Nick Studnicka**

- Upgrading the lighting to LED should be finished end of June
- SLP kicks off this year's Summer Library Program (SLP) is "Adventure Begins at Your Library" sign ups starts on June 3rd and the first event is Monday, June 10 with a Free Family Flick at 1pm.
- The last Mid-Morning Matinee for the season is Thursday, May 30 at 11:30 am and we will be showing Clouds. Past Mid-Morning showings were Singing in the rain in April, Secondhand Lions in March.
- Zoozort Monday, June 17 at 1:00 pm. This is a ticketed event and tickets will be available free of charge starting the day of the event. Space is limited; it is recommended to show up early.
- Starting this past February the Plain, Lone Rock, Spring Green libraries have been offering tech help once a month at each library from 2-4
- Looking at a major upgrade of the exterior of the building, adding gutters, large patio area, and updating landscaping
- Order two new pcs to replace older pcs

## **Ruth Culver Community Library – Prairie du Sac – Lauren White.**

- **Corcoran Puppets:** June 10 at 1PM: Pam Corcoran is bringing her puppets and theater to the library for a unique presentation of The Three Little Pigs. She will also be demonstrating how the puppets work and talking a little bit about how they're made.
- **Dairy Day at the Library:** June 17 at 1PM: We are partnering again with Prairie Raised Beef to bring in some farm animals and some fun farm education to the library. This event will be outside the library weather permitting and will have a few different stations for kids to experience.
- **Tunes for Tots:** We have a new music program in our Friday 10AM slot for the summer! Tunes for Tots will be focused on helping 3 and 4-year-olds develop their musical abilities and singing voice. The sessions will build on each other, so participants are encouraged to attend as many as possible over the summer.
- **Wind Spinners:** June 10 will be an adult craft event making patriotic wind spinners.
- **Sound of Science:** Laura Lang provided us with a fantastic sound program. She demonstrated lots of different sound makers from all over the world and talked about soundwaves and vibrations. Afterwards, kids were able to make their own rain-stick to take home and try a lot of the experiments for themselves.

- **Early Release:** Domino Rally and Snack Break: After watching a few domino set-ups while snacking, kids got to work on building their own creations. The beginning challenge was to build a straight line across a table. We would measure the length and then see how long it would take to fall once it was going. After counting up the dominos, we could calculate the number of dominos falling per second. The second part was a free build phase where kids could build towers, bridges, and more to add complexity to their domino lines.
- **Art Explorers Series:** It's been a messy 8 weeks of art exploration! We did quite a variety of activities including painting, dough-shaping, pasta gluing, foam painting, and more. The adults that brought their kids expressed gratitude for the opportunity to do these art projects and then be able to focus on helping the child(ren) clean up without worrying about the mess around the art. A big thank you to the Friends for their support in helping us stock up on supplies for this series of programs!
- **WAPL Conference:** Bethany, our children's librarian, attended the Wisconsin Association of Public Libraries Conference in Stevens Point, Wisconsin. She attended several relevant sessions on early literacy, programming resources, and outreach in small communities.
- We participated in free comic book day (May 4th) again this year and gave out close to 200 comics. Leftover comics will be left out for patrons to take as well.
- The April event for adults was a presentation May 6 on Georgia O'Keeffe's life and art and her connection to Sauk Prairie.
- Lauren is participating in the virtual ILS evaluation, which was last done in 2017. While not involved in an official capacity, it's important to be familiar with what is available to libraries.
- Since January 1, 2024, our teen snack cabinet has distributed 2,759 items! Heather is now working with Family Dollar to boost donations further. They now have a table set up in-store with items that are deeply discounted—people can purchase those items for the library and then Heather picks them up to add to our stockpile. Over spring break we did break into some of the undesignated funds to supplement spring break snacking and it was much needed.
- SP CAN has selected *The Midnight Library* by Matt Haig as their 2024 read. Discussions are ongoing as we organize a discussion panel and film screening

### **Rock Springs Community Library – Rebecca Anderson**

**PROGRAMS:** With our Monday morning program, **The Gathering**, we have had a presentation on the Sunbonnet Sue Quilt tradition and transformation from Homemaker presenter Jean Brew from Wisconsin Dells and a no-knead bread presentation from Sandra Byers who is from Rock Springs and who also is one of the artisans from Byers Stoneware Pottery.

We have not had a good show at all this year for our **After-School** program. In **The Littles Story Time**, we have had story themes of Snow Day, Valentine's Day, Teeth, the Alphabet, Fairy Tale Science, Rainbows, Spring Time, Easter & Bunnies, Weather/Rain, Birds, Garden and Seeds where the children got to spoon in dirt and a few seeds into containers. We read about dinosaurs, cats and dogs, Mother's Day, Families and how different they are today, and Turtles. One of our patrons brings in birthday cupcakes the last Wednesday of the month. We sing Happy Birthday and there is usually someone in the group that has or will have a birthday.

The **Homeschool Group** has had a faithful few families. In between Free Time, we have had projects where we made truffles in the kitchen, explained how Transparent Language works starting from our website. We did a Fairy Tale Science project in the kitchen testing various rafts using craft sticks, straws, and paper clips to see what raft floats the best. We also did a planting of seeds and read about the parts of a seed and then had worksheets for the students to fill out. They made Mother's Day cards and we also had our 3<sup>rd</sup> Annual Talent and Show 'N' Tell Show and followed that with pizza and conversation.

**WEBSITE UPDATES:** We have added a Vet Vision Care Guide to our website link to our front page as well as updated our calendar to show program events. (With our regular calendar, we can show program times, but still need to figure out how to add a specific program title.) We have also added a Guide for Seniors on Fentanyl info.

**RECOLLECTION WISCONSIN:** Shane Harvey and Margo Busser have received a good response from a few new volunteers: Jacky Kruse and Joy and David Carroll. They have been getting together to learn about how to do the scanning of photos and entering metadata.

**UPDATE ON THE BUILDING:** The cracks on our Circulation wall have been addressed with trim and paint. The wall has continued to crack. There has also been a discovery that the ceiling paint used has a sheen to it. All of the ceiling paint shows a matt finish. There is a lot of ceiling paint left over. The Village Board is discussing with Harmony whether any of the ceilings have the ceiling paint or were only painted with the primer.

**Summer Reading Program:** We received an order from Collaborative Summer Library Program for posters, stickers, bookmarks, and t-shirts. We have been figuring out library display areas focusing on camping and adventures, air balloon props with book characters in the baskets, and various activities like softball, a hike in Ableman's Lower Gorge, and sidewalk chalk as a part of our reading program this summer. We will have a reading log with small prizes after completion of a set number of books.

## **George Culver Community Library, Sauk City - *Kylee Bear***

### **Staffing Updates**

- My first day as director was on April 1.
- First priority was filling multiple vacant positions that had been open throughout the interim. Staff put in A LOT of extra hours in that time and are thrilled to finally be back to fully staffed levels.
- Will have 2 more library assistant openings at the end of summer due to student workers leaving for college, but the recent budget increase at beginning of 2024 has been incredibly impactful on employment interest.

### **Programs/Events**

- Eclipse Party: We had great turn out for our eclipse party on April 8 with around 120 attendees across all age groups! We enjoyed sun themed snacks, got creative with crafts and photo ops, and then gathered on our patio to view the eclipse at its peak.
- Programming slowed down a bit during the interim, besides our ongoing youth storytimes, bimonthly bingo hosted by our Friends, and a monthly book club for adult patrons. I will be taking over book club and am prioritizing bringing adult programs back to the library. Immediate plan is to resume "Book-A-Librarian" sessions and offering instructional technology classes.
- Our Summer Reading Program will kick off on Monday, June 10. We have collaborated with Ruth Culver Community Library for the children-level program.

### **Upcoming Events**

- Library Explorers Adventure Program – Weekly program that will begin on Wednesday, June 12 at 11:30am for school age children. With the help of local experts, they'll learn a new outdoor skill each week.
- Live Raptor Program – Saturday, June 15 at 1pm. Samantha Brooks with The Raptor Education Group will present a program that features 4 to 5 different live birds of prey.
- Starlab Planetarium – Saturday, July 13 at 11:30am. Presented by Paul Kinzer, director of Seeing Stars, patrons will have the opportunity to learn more about astronomy from inside a portable and immersive planetarium

### **Other**

- The library will be celebrating 100 years of official service in 2024. I will be collaborating with our Friends group to host a centennial celebration, likely sometime in the fall.

## **LaValle Library – Natalie Jones**

Since the Holidays, the Amazon wish list donations have topped 110 books. The outpouring of support—from near and far—has been amazing.

Friends held their first Storytime April 18th with book reading by a fireman and then a tour of the fire station next door. They will hold their next Storytime June 20th. May 18th Friends hosted ZooZort at the LaValle Community Center, the old elementary school. With over 200 people in attendance it was a wise decision to utilize the space of the Center. Plus it familiarizes the community with the Center. The Library is working on doing more programming in conjunction with the Center.

We received a \$10,000 grant from the ALA Libraries Transforming Communities: Accessible Small and Rural Communities. The grant is focused on disabilities. We did hold a Community Conversation which we wanted feedback on ways we could better serve unknown disabilities. While we are likely to install an automatic door on the back of the building with the funds, conversation led to offering other items in the library geared towards helping ADD/ADHD. Items were actually put on the Amazon list and various items have already arrived.

We are offering a Summer Reading Challenge for all ages. I found a new volunteer to run various summer children's programming. A couple simple events and we'll hold the Library Olympics again in August.

## **Reedsburg Public Library – Sue Ann Kucher**

Busy with Summer preparation; Reading program begins June 1; summer kickoff event June 11, sharing info on 400 trail, City parks & local adventures to be had right in Reedsburg. Summer preparation included visits to all of the Reedsburg schools as well as the Weston district

A generous donor matched the May book sale proceeds.

3 staff are scheduled to go on library visits to other system libraries in June; we're hoping to plan further visits for staff as a staff enrichment opportunity.

New Youth Services Librarian, Heather Johnson started mid-February. Half-time Youth Services Assistant, Stephanie Baldwin-Curtis started in May.

Staff member attended the Sauk Co Institute on Leadership. Highly recommend it.

Library is celebrating 125 years of service to the community in 2024. We also anticipate circulating our 6 millionth item from the current Vine Street Library sometime this fall.

# Sauk County Library Service Plan 2025-2030

**1. MISSION STATEMENT:** The mission of the Sauk County Library Board is to provide high quality library service to all residents in the most accountable and efficient manner.

**2. INTRODUCTION:** Sauk County maintains a library service under the authority of Wisconsin Statute 43.57 to serve the residents of the county who do not live in municipalities that have established libraries or to improve the library service of municipal libraries.

The Sauk County Library Board has operated a county library service since 1964. From 1964 to 1975, the county library service provided direct services to libraries including consultant services, materials, grant administration, and bookmobile service. In 1975, Sauk County joined the newly formed South Central Library System.

Library service to county residents, rural and urban, is provided by 10 libraries in Sauk County with assistance from county funds. Those public libraries are in the communities of Baraboo, LaValle, North Freedom, Plain, Prairie du Sac, Reedsburg, Rock Springs, Sauk City, and Spring Green. Since part of the city of Wisconsin Dells, and the entirety of Lake Delton are within Sauk County, per statute 43.12 it receives funds based on its service to Sauk County residents; it is reported as a Sauk County library throughout this document.

The Sauk County Library Board meets at least quarterly. The Sauk County library directors also meet quarterly, or more often as the need arises. The Sauk County Library Board contracts with one library in the county to provide the administrative services required by the library board and to complete state reporting mandates.

Sauk County participates fully as a member of the South Central Library System and receives the full range of system services. Sauk County supports representation on the SCLS board, as provided in s. 43.19(1)(b)(2).

### 3. CURRENT SERVICES TO COUNTY RESIDENTS

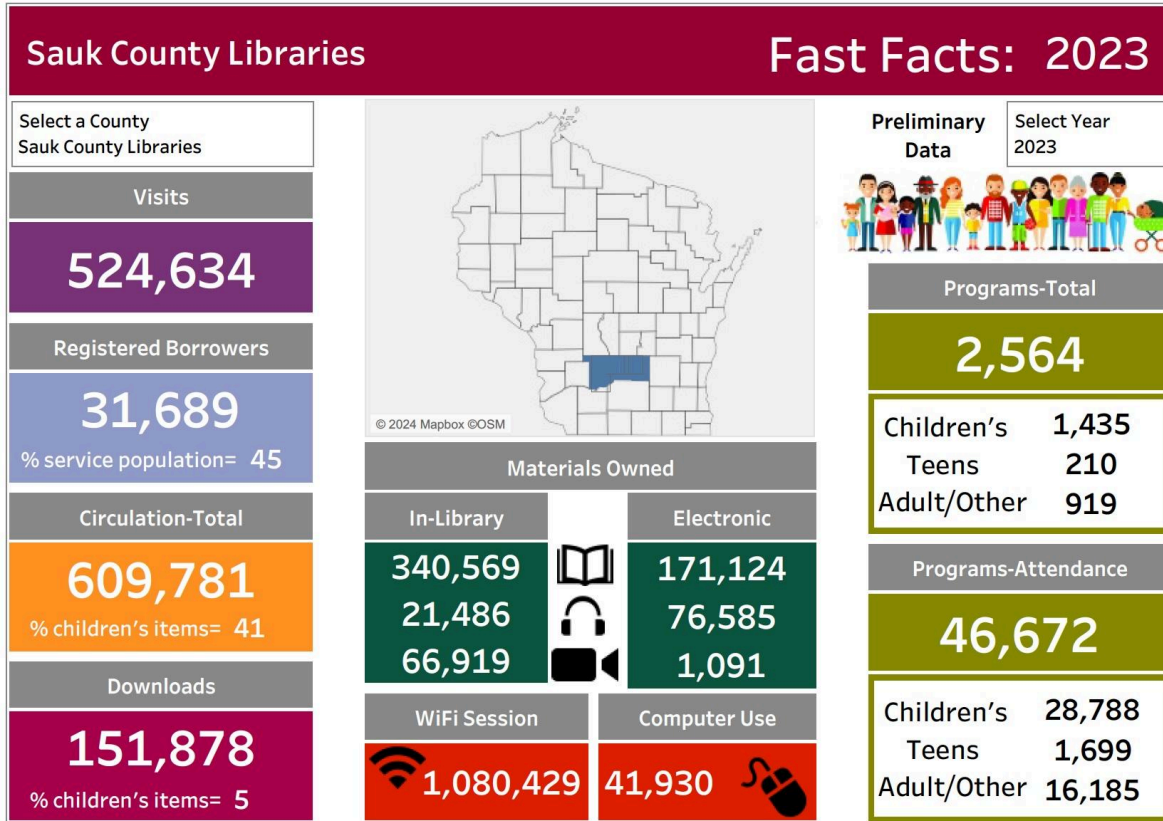
- a. County libraries may provide the following materials and services to all library users:
- 24/7 access to shared library catalog (LINKcat), shared databases and digital collections via computers and mobile devices.
  - Leisure materials – Books in a variety of physical and digital formats, music, movies, periodicals and unique collections including tools, equipment kits and technology.
  - Research Materials - Local history resources, databases, microfilm readers and skilled reference staff.
  - Room use with video conferencing capabilities
  - Equipment - Audiovisual equipment, fax machines, scanners, photocopiers, typewriters and other communication equipment.
  - Internet access – High-speed bandwidth, computers for public use, wireless internet, and mobile access devices.
  - Training - Computer assistance, youth and adult literacy programs, exam proctoring, resources for job searching and skills, language training and assistance with identifying and navigating available resources.
  - Programming for all ages – Literacy programs, discussion groups, creative programs, cultural displays, summer reading programs.
  - Community Outreach - Homebound delivery, community information, public meeting spaces, and collaboration with community organizations and resources.
  - Safe, neutral community spaces for everyone to meet, interact and exchange ideas.

b. The ten libraries serving Sauk County have been established under Wisconsin Statute 43.52 and 43.53. The libraries are governed by municipal library boards under State Statute 43.54 as shown below:

- Baraboo - 9 members, recommended by the Board and appointed by the City of Baraboo
- La Valle - 5 members appointed by the Village President. The board is made up of 3 Village residents and 2 members from outside the village.
- North Freedom - 5-7 member board, recommended by the Library Board, with the approval of the Village Board.
- Plain - 7 member board, recommended by the Library Board; appointed by the Village of Plain
- Prairie du Sac - 7 member board, appointed by the Village of Prairie du Sac.
- Reedsburg Public Library - 7 members, appointed by Reedsburg's Mayor, confirmed by Common Council
- Rock Springs - 5 member board, appointed by the Village of Rock Springs
- Sauk City - 7 member board, appointed by the Village of Sauk City
- Spring Green - 7 member board, appointed by the Spring Green Village President with approval of the Village Board of Trustees
- Kilbourn Library - Joint library, serving Wisconsin Dells and Lake Delton; 7 member board. 3 appointed by the City of Wisconsin Dells, 3 appointed by the Village of Lake Delton and one representative from the Wisconsin Dells School District.

Sauk County has established county library services under Statute 43.57(3) to serve the residents of the county who do not live in municipalities that have established libraries and to improve the library services of municipal libraries established under s. 43.52 or 43.53. The Sauk County Library Board is a 7 member board. Potential candidates are referred by the Sauk County Library Board, appointed by County Administrator and confirmed by the Sauk County Board of Supervisors.

c. Current library usage statistics for county residents:



This infographic includes statistics for the Kilbourn Library of Wisconsin Dells as a Sauk County Library. The Kilbourn Library is a joint municipal library serving Wisconsin Dells and Lake Delton. The library is located in Columbia County. The City of Wisconsin Dells sits within Adams, Columbia Juneau and Sauk Counties. The Village of Lake Delton is located in Sauk County.

4. CURRENT FUNDING OF LIBRARY SERVICES TO SAUK COUNTY RESIDENTS:

a. County payment for library service is governed by Statute 43.12, specifying, in part:

*The minimum amount under par. (a) shall be calculated to equal 70 percent of the amount computed by multiplying the number of loans of material made by the library during the prior calendar year, for par. (a) 1. or 3., to residents of the county who are not residents of a municipality that maintains a public library under s. 43.52 or 43.53, or, for par. (a) 2., to residents of the county who are not residents of a municipality that contains a branch of the consolidated library, as reported under sub. (2), by the amount that results from dividing the total operational expenditures of the library during the calendar year for which the number of loans are reported, not including capital expenditures or expenditures of federal funds, by the total number of loans of material made by the public library during the calendar year for which the loans are reported.*

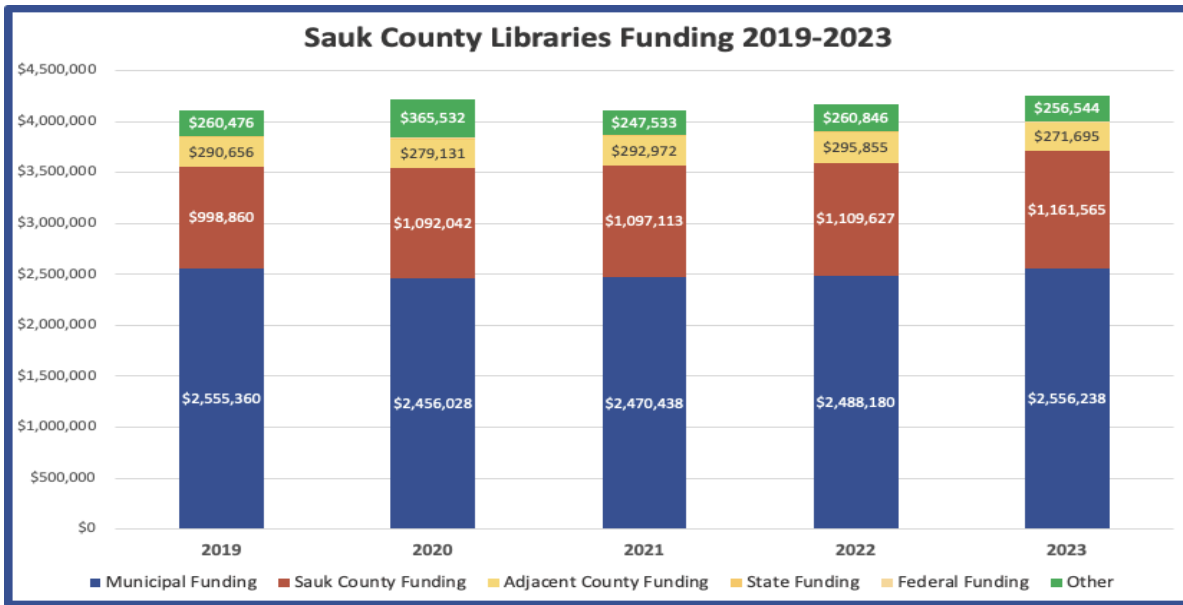
Sauk County has historically provided 100% reimbursement funding to County Libraries for use by rural residents. Additionally, Sauk County has provided a portion of the funding for county libraries to receive materials delivery from SCLS 5 days per week as well as technology funds to help ensure libraries are able to keep technology and training up to date for staff and library users.

The listed municipalities have historically resolved to be exempted from the county library tax, opting to appropriate and expend an amount at least equal to the to the county library tax rate in the prior year multiplied by the equalized valuation of property in the city or village for the current year, in accordance with Statute 43.64(2)(b).

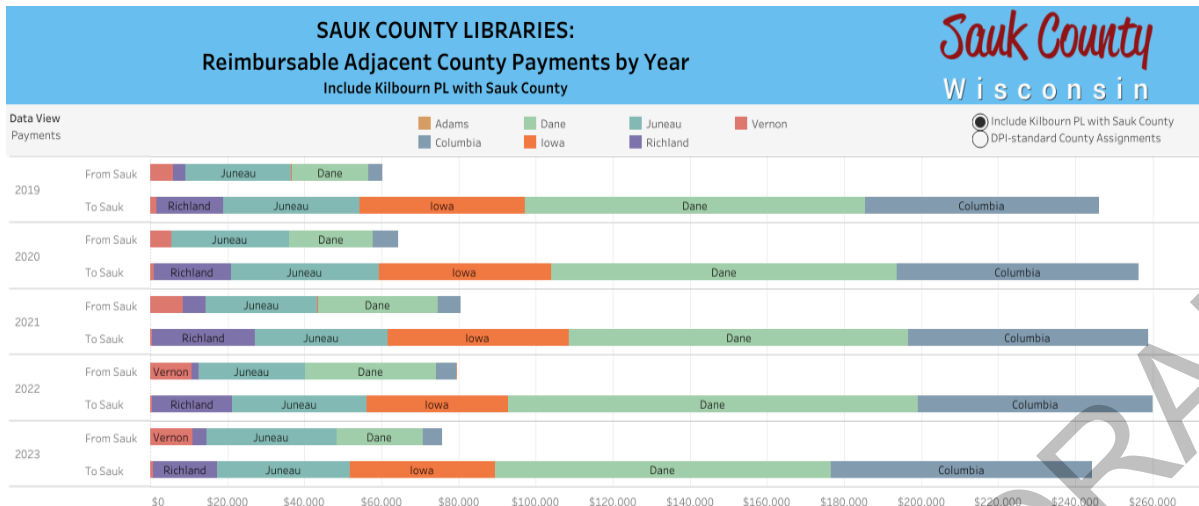

**5. SERVICE PLAN GOALS AND OBJECTIVES** Seven goals have been adopted by the Sauk County Library Board as being essential to maintain and enhance quality library service for all rural residents of Sauk County.

**Goal 1: Ensure a basic level of service for all county residents. Sauk County Libraries will meet statutory service standards and basic level standards from DPI Wisconsin Public Library Standards, including open hours, staffing levels, collections, and access to technology.**

#### **IMPLEMENTATION**

1.1 The Sauk County Library Board will encourage all county libraries to strive for at least a basic level of service based on service population, as established by the Department of Public Instruction's set of Wisconsin Public Library Standards.

1.2 The Sauk County Library Board will require quarterly reporting reflecting services standards from municipal libraries. An annual output performance report derived from the DPI Annual Reports will be used in the evaluation of services provided by libraries to rural residents. Libraries that need assistance in order to meet these standards will work with the Sauk County Library Board, the South Central Library System and other county libraries to create an action plan to improve services.

#### **GOAL 2: Obtain funding for public libraries serving rural Sauk County residents.**

The Wisconsin Statutes provide for the funding of established municipal libraries. Utilizing data provided by each library's Wisconsin Department of Public Instruction Public Library Annual Report, this funding formula utilizes each library's expenditures, divided by the library's annual circulation of physical materials to develop a "cost per circulation". This figure is multiplied by the number of physical materials checked out by rural residents to determine county reimbursement for library services. While circulation is the metric for determining the reimbursement amount, that figure is representative of all services and programming offered to library users.

Reimbursement for services to rural Sauk County residents as well as services to rural residents in adjacent counties utilizes the established funding formula. Municipalities who elect to exempt from the county library tax are required to provide support at a rate at or above the county's library tax rate.

#### **IMPLEMENTATION**

2.1 Advocate for the necessary funding to ensure libraries are able to maintain their existing level of service and continue to meet the needs of county residents as our communities change.

2.2 Require Sauk County public libraries to provide annually the necessary information to determine their "unit cost" per circulation in order to receive a county payment for library service.

2.3 Sauk County public libraries shall seek reimbursement for services provided to residents from adjacent counties.

2.4 The Sauk County Library Board will be an active partner in determining alternative mechanisms for equitable funding.

**Goal 3: Continue funding for a designated library to provide administrative support to the Sauk County Library Board and to coordinate joint activities of the Sauk County library directors.**

The Sauk County Library Board has no access to county administrative services; instead, the Board designates one library in the county to provide needed administrative support and to compile annual report data. The designated library also provides desired services to the rest of the libraries in Sauk County.

**IMPLEMENTATION**

- 3.1 The Sauk County Library Board will allocate county funds to a designated library to allow it to act as a resource library in the capacity required by the Sauk County Library Board and member libraries.
- 3.2 The Sauk County Library Board and library directors will annually review the services provided by the designated library for possible changes.

**Goal 4: Maintain funding assistance from the county for delivery service.**

Of the delivery costs not paid by the South Central Library System, the county funds a 2/3 share and the municipal libraries fund the remainder, with libraries receiving 5-day delivery.

**IMPLEMENTATION**

- 4.1 The Sauk County Library Board will annually evaluate the county funding percentage for delivery service.

**Goal 5: Continue County funding to assist libraries in meeting technology needs.**

Technology is increasingly important to maintaining the relevance of libraries. The county library board has provided a line item to assist libraries in upgrading existing technology and introducing new technology.

**IMPLEMENTATION**

- 5.1 The Sauk County Library Board will advocate for appropriate funding for technology.
- 5.2 The Sauk County Library Board and Sauk County library directors will review technology spending on a yearly basis.

**GOAL 6: Encourage Sauk County libraries to seek and provide services to those who experience barriers to traditional library services.**

Sauk County libraries serve diverse populations and strive to meet the needs of our communities by providing equitable access to residents from all backgrounds, interests and abilities.

**IMPLEMENTATION**

6.1 Support libraries in actively engaging their communities to successfully identify community needs and barriers and develop services and programming in response.

6.2 Encourage libraries to collaborate with other libraries, agencies and organizations to offer programming and services to meet needs and eliminate barriers in our county.

**GOAL 7: Promote libraries and inform residents about the wide range of services and resources available from the county libraries.**

**IMPLEMENTATION**

7.1 The Sauk County Library Board and library directors will work together to inform the Sauk County Board of Supervisors of programs, services and library usage statistics, throughout the year, through print, social media and face-to-face interactions.

7.2 Share annual reporting of library services provided by Sauk County libraries to the County Board of Supervisors as part of the budget process.

7.3 Utilize community connections to invite input from county residents.

7.4 Partner with county-wide services, governmental agencies and other county and area libraries and schools to promote libraries, resources, and services offered to users.
