ON SATURDAY, 4/4/2020, AT APPROXIMATELY 4:45 PM, UNIT 1, A BIEGE TOYOTA HIGHLANDER, BEARING WI REGISTRATION # ACF6739, WAS BEING DRIVEN SOUTHBOUND ON US 12 BY THE SOLE OCCUPANT ERMA J HAASE. UNIT 1 WAS IN THE LEFT HAND LANE AND CROSSED THE CENTER LINE, ENTERING THE MEDIAN DITCH. UNIT 1 CONTINUED TO GO SOUTHBOUND AND FURTHER INTO THE DITCH UNTIL UNIT 1 STRUCK A CULVERT. UPON HITTING A CULVERT, UNIT 1 SPUN AROUND IN A COUNTER CLOCKWISE FASHION AND ROLLED OVER ONTO ITS ROOF. BOTH FRONT AND SIDE AIRBAGS WERE DEPLOYED. THE DRIVER WAS NOT TRAPPED, BUT COMPLAINED OF NECK PAIN. THE DRIVER ADVISED SHE WAS REACHING OVER TO THE PASSENGER SIDE FLOOR BOARDS AND WAS NOT WATCHING THE ROADWAY WHEN SHE LEFT THE ROADWAY. THE DRIVER WAS TRANSPORTED BY SAUK PRAIRIE EMS TO SAUK PRAIRIE HOSPITAL. THE VEHICLE WAS REMOVED BY EVERETT'S TOWING.
