ON THE DESCRIBED DATE, TIME, AND LOCATION, UNIT 1 WAS TRAVELING EASTBOUND. AS THE OPERATOR WAS ATTEMPTING TO NEGOTIATE A CURVE, SHE LOST CONTROL OF UNIT 1. UNIT 1 ENTERED THE DITCH LINE. THE OPERATOR WAS ABLE TO BRING UNIT 1 BACK ON TO THE ROADWAY FOR A BRIEF PERIOD, BUT OVER CORRECTED CAUSING UNIT 1 TO RE-ENTER THE DITCH AND OVERTURN. THE OPERATOR STATED SHE REACHED DOWN TO GRAB HER CUP OF COFFEE WHEN SHE LEFT THE ROADWAY. THE OPERATOR SUFFERED MINOR INJURIES, BUT REFUSED TRANSPORTATION TO THE LOCAL HOSPITAL.
