UNIT WAS SOUTH BOUND ON THOMPSON RD GOING AROUND A CURVE UPHILL ON ICY SLUSH COVERED ROADWAY. OPERATOR STATED HE WAS TRYING TO TURN HIS STEERING WHEEL BUT THE UNIT WOULDN'T TURN AND WENT STRAIGHT OFF ROADWAY ABOUT 10 FEET WHERE IT STRUCK A ROCK EMBANKMENT AND OVERTURNED ONTO THE DRIVERS SIDE AND STOPPED. OCCUPANTS GOT OUT ON THE PASSENGER SIDE. OPERATOR HAD A SMALL CUT TO A FINGER. THERE WERE NO OTHER INJURIES. UNIT HAD DAMAGE TO SEVERAL AREAS. STEVES TOWING RESPONDED. TOW COMPANY PULLED THE VEHICLE UPRIGHT AND OFF OF THE ROADWAY TO A SAFE LOCATION. DUE TO SOME UNDER CARRIAGE DAMAGE, UNIT COULD NOT BE DRIVEN AWAY. OPERATOR RETURNED WHEN ROAD CONDITIONS IMPROVED AND TOWED THE VEHICLE HOME.
