ON MONDAY, 3/15/2021, AT APPROXIMATELY 4:50 PM, UNIT 1, A 2017 GRAY FORD FUSION, BEARING WI REGISTRATION PLATE #AHA7169, WAS BEING DRIVEN BY MICAH P. WALTERS. UNIT 1 WAS WEST BOUND ON STH 60 WITH STARTING LOCATION OF COLUMBUS, WI, WITH A DESTINATION OF RICHLAND CENTER, WI. THE ROADWAY OF ICY, SLUSHY, AND SNOW COVERED WITH THE WEATHER BEING SNOWING. UNIT 1 CRESTED A HILL AND WAS NEGOTIATING A LEFT CURVE ON STH 60 WITH A SPEED LIMIT OF 55 MPH. UNIT 1 AFTER NEGOTIATING A CURVE CONTINUED LEFT, ACROSS THE CENTER LINE, INTO THE OPPOSITE LANE'S DITCH AND STRUCK A LANE SHIFT/CURVE ROAD SIGN. UNIT 1 REMOVED ITS SELF FROM THE DITCH AND PARKED AT CASSEL ROAD. THE DRIVER REPORTED THE ACCIDENT AND WAS UNINJURED. THE VEHICLE WAS REMOVED BY FOUR WAY TOWING.
