UNIT WAS NORTHBOUND ON OLD LOGANVILLE RD NORTH OF STH 23 NEGOTIATING CURVES ON A WINDY DOWNHILL ROADWAY. OPERATOR STATED HE GOT OFF INTO THE GRAVEL ON THE RIGHT SIDE OF THE ROAD. OPERATOR STATED HE TRIED TO STEER IT BACK OVER, THEN OVER CORRECTED, CAUSING HIM TO LOSE CONTROL. UNIT CONTINUED NORTHWEST ACROSS THE ROADWAY FOR ABOUT 100 FEET, WHERE IT ENTERED THE WEST/ LEFT SIDE DITCH. UNIT THEN STRUCK AN EMBANKMENT NEXT TO THE DITCH THEN TRAVELED ABOUT 25 FEET FURTHER NORTH WHERE IT STRUCK A SMALL CULVERT, THEN CAME TO REST ON THE CULVERT FACING NORTH EAST. REEDSBURG FIRE AND EMS RESPONDED. THE OPERATOR WAS NOT INJURED. A FRONT SEAT PASSENGER HAD A BUMP ON HER HEAD. SHE WAS CHECKED AT THE SCENE, BUT REFUSED TRANSPORT. THE UNIT WAS TOWED BY STEVE'S AUTO. THE OPERATOR WAS LATER CITED FOR OPERATING TOO FAST FOR CONDITIONS.
