U1 WAS A 1994 GREEN CHEVROLET SUBURBAN. OPERATOR OF U1 WAS SIDNEY POPPLE. OPERATOR WAS TRAVELING NORTHBOUND ON S. SHORE RD., WITH THREE OCCUPANTS. OCCUPANTS WERE MALICHI RAINES, EMILY RAMIREZ, AND FRANCISCO ROBLES. U1 OPERATOR ADMITTED TO CONSUMING ALCOHOL PRIOR TO DRIVING. OPERATOR OF U1 STATED HE WAS GOING AROUND THE CURVE TOO QUICKLY AND LOST CONTROL. U1 WAS NAVIGATING THE CURVE WHEN IT ENTERED THE OUTSIDE SHOULDER THEN OVER CORRECTED. WHICH IT THEN CROSSED THE CENTER OF THE ROADWAY IN A SIDEWAYS MANNER. U1 CONTINUED ACROSS THE ROADWAY AND ENTERED THE DITCH OF THE ONCOMING LANE AND STRIKING A TREE. U1 THEN SPUN SIDEWAYS AND LANDED ON IT'S PASSENGER WHEELS AGAINST A TREE WITH THE DRIVER SIDE WHEELS IN THE AIR. EMILY RAMIREZ AND MALICHI RAINES WERE EJECTED FROM THE VEHICLE. NO OCCUPANTS IN THE VEHICLE WERE WEARING SAFETY BELTS AND NO AIRBAGS DEPLOYED. VEHICLE REMOVED BY CRAIG'S TOWING. EMILY AND MALICHI WERE TRANSPORTED BY AMBULANCE THEN TRANSPORTED BY MEDFLIGHT. SYDNEY AND FRANCISCO WERE TRANSPORTED VIA AMBULANCE. ALSO A DOG WAS LOCATED RUNNING AWAY FROM THE CRASH SCENE AND GIVEN ANIMAL CONTROL.
