UNIT 1 WAS TRAVELING NORTH ON HIGHWAY 23 NORTH OF FELDMAN ROAD. OPERATOR STATED THAT HE WAS NODDING OFF BUT WAS CLOSE TO HOME AND WAS TRYING TO MAKE IT HOME FROM PLATTEVILLE BEFORE HE FELL ASLEEP. HIGHWAY 23 MAKES A LEFT HAND GRADUAL CURVE AT ELDER RIDGE ROAD. UNIT 1 FAILED TO NEGOTIATE THIS CURVE AND ENTERED INTO THE DITCH ON THE EAST SIDE OF THE ROADWAY. UNIT 1 TRAVELED APPROXIMATELY 15 YARDS IN THE DITCH BEFORE STRIKING A CULVERT AND CAUSING SEVERE DAMAGE TO THE VEHICLE. OPERATOR STATED HE WAS SORE BUT CLAIMED NO INJURIES AND DENIED EMS ON SCENE. UNIT 1 REMOVED FROM SCENE BY STEVES TOWING.
