THE OPERATOR THEN STATED SHE LOOKED UP AND THOUGHT SHE WAS GOING TO GET HIT ON ONCOMING TRAFFIC AND SWERVED OFF THE ROADWAY. MARKS ON THE ROADWAY APPEAR TO SHOW THE OPERATOR OVER CORRECTED AFTER LEAVING THE ROADWAY CAUSING HER TO LOSE CONTROL OF THE VEHICLE AND RE ENTER THE DITCH AND HITTING A TREE. NO INJURIES WERE REPORTED AND WEGNERS CAME AND TOWED THE VEHICLE.
