UNIT 1 WAS S/B ON US HY 12. UNIT 1 DEVIATED FROM THE ROADWAY ON THE WEST SIDE OF THE ROAD. UNIT 1 ENTERED THE DITCH, PROCEEDED THROUGH A FENCE AND THEN ROLLED DOWNHILL. UNIT 1 CAME TO REST WITH THE DRIVER'S SIDE DOOR ON THE GROUND, AND PASSENGER'S SIDE DOOR FACING THE SKY. OPERATOR OF UNIT 1 WAS TRAPPED IN THE VEHICLE AND EXTRICATED BY FIRE DEPARTMENT. CRASH WAS DISCOVERED BY A COUNTY EMPLOYEE APPROXIMATELY 6 HOURS AFTER IT OCCURRED.
