UNIT 1 WAS E/B ON HY 136, WEST OF RAVEN ACRES DRIVE. UNIT 1 WAS ON A STRAIGHT SECTION OF ROAD APPROACHING A CURVE TO THE LEFT. OPERATOR OF UNIT 1 ADVISED A VEHICLE CAME AROUND THE CURVE, WESTBOUND, IN HER LANE OF TRAFFIC FOR NO APPARENT REASON. OPERATOR STATED SHE SWERVED OFF THE ROAD TO AVOID A HEAD ON COLLISION. UNIT 1 CROSSED PART OF A YARD, AND THEN STRUCK A BRICK FIRE-PIT NEAR A HOUSE. THE COLLISION WITH THE FIRE PIT DESTROYED THE FIRE PIT AND BROUGHT THE CAR TO A STOP. THE AIRBAGS DEPLOYED AND THIS CAUSED DAMAGE TO THE FRONT OF UNIT 1. THE OWNERS OF THE PROPERTY WERE ADVISED, BUT LIVE AT A DIFFERENT ADDRESS AND DID NOT RESPOND TO THE SCENE IN PERSON.
