UNIT 1 WAS TRAVELING WESTBOUND ON NORTH REEDSBURG ROAD APPROACHING ROSEY LANE. UNIT 1 PASSED A VEHICLE AND A WITNESS STATES THE VEHICLE WAS TRAVELING TOO FAST FOR CONDITIONS. UNIT 1 ATTEMPTED TO NEGOTIATE CURVE, STRUCK A DITCH AND ROLLEVER IN THE YARD OF S3089 N REEDSBURG ROAD CAUSING DAMAGE TO THE YARD. THE OPERATOR THEN LEFT THE SCENE ON FOOT AND WAS FOUND A SHORT TIME LATER NEAR THE CRASH SCENE. UNIT 1 WAS REMOVED BY CRAIG'S TOWING. UNIT 1 OPERATOR WAS ARRESTED AND CITED FOR OPERATE A MOTOR VEHICLE WHILE UNDER THE INFLUENCE, OPERATOR A MOTOR VEHICLE WITHOUT INSURANCE, OPERATE A MOTOR VEHICLE WITHOUT A VALID LICENSE 2 WITHIN 3 YEARS, POSSESS OPEN INTOXICANT IN MOTOR VEHICLE BY DRIVER AND HIT AND PROPERTY ADJACENT TO HIGHWAY. MINOR INJURIES WERE SCENE ON OPERATOR BUT HE REFUSED TREATMENT.

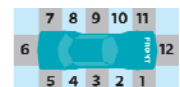
