UNIT 1 WAS TRAVELING SOUTH ON HWY T NEAR GILLEM RD. THE ROADWAY WAS DRY BUT HAD SALT RESIDUE ON IT. UNIT 1 LEFT THE ROADWAY AND STRUCK A ROAD SIGN ON THE WEST SIDE OF THE ROADWAY. THE ROAD SIGN WAS KNOCKED DOWN AND DAMAGED. THE OPERATOR OF UNIT 1 WAS ABLE TO GET THE VEHICLE UNSTUCK AND DROVE AWAY FROM THE SCENE WITHOUT NOTIFYING LAW ENFORCEMENT. UNIT 1 WAS OBSERVED LEAVING THE SCENE AND A TRAFFIC STOP WAS CONDUCTED. THE OPERATOR WAS INTOXICATED AND ARRESTED FOR OWI 3RD OFFENSE. THE OPERATOR STATED THEY WERE NOT INJURED BUT MEDICAL CLEARANCE WAS OBTAINED. THE OPERATOR STATED THEY HAD INSURANCE BUT WERE NOT ABLE TO PROVIDE A COPY OF IT. THE VEHICLE HAD DAMAGE TO THE PASSENGER SIDE AND REAR AREA. THE VEHICLE WAS TOWED BY CRAIGS TOWING.

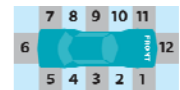
