UNIT 1, BEARING WISCONSIN REGISTRATION PLATE #ML9699, WAS BEING DRIVEN BY STEVEN J. BARRITT. UNIT 1 WAS SOUTHBOUND ON STH 136 AND CAME TO THE INTERSECTION OF SKILLET CREEK, POINT OF ROCKS ROAD, AND STH 136 EASTBOUND. UNIT 1 TURNED LEFT IN WHICH STEVEN FAILED TO NEGOTIATE THE TURN BY CROSSING INTO THE ONCOMING LANE OF TRAFFIC AND STRUCK THE STOP SIGN CAUSING DAMAGE TO THE FRONT PASSENGER CORNER PANEL/FRONT BUMPER. THIS CAUSED THE STOP SIGN TO BE KNOCKED DOWN AND DAMAGED. SAUK COUNTY HIGHWAY DEPARTMENT WAS NOTIFIED, RESPONDED TO THE SCENE AND PUT UP THE STOP SIGN.
