7. Sauk County Animal Shelter operations update and budget presentation:

Animal Shelter took in 32 dogs and adopted/reclaimed 35 dogs. They also took in 59 cats and adopted out/transferred out 24 in the month of March. The Animal Shelter also took in 4 guinea pigs and 2

parakeets and 1 rabbit. They adopted out 2 guinea pigs. The Animal Shelter dealt with a total of 2 bite cases both dogs. They responded to 30 calls and impounded 13 dogs, 10 cats.


Information that our Blood Draws for the first 3 months was \$1,200 compared to a total of \$3,125
